FINANCIAL REPORT

The Health District is up in environmental fees over prior year. Also, grant money for covid 19 and billing for covid vaccination administrative fees are expected to cover additional costs for covid activities by the Health Department.

WORKLOAD UPDATE

Environmental workload is up over last year and is expected to remain strong through the fiscal year. Salon, pool and restaurant licensing renewal forms will be going out within the next few months.

PROGRAM /COVID 19 UPDATES

Phep and MRC programs are continuing with additional grants from Naccho. Covid Grant money has come in and help cover the Health District's contact tracing, vaccination program, etc. The Health District has given over 7000 vaccinations for the covid 19 pandemic and continues dose 2's through April. Additional vaccines will be given based on availability after April.

OTHER BUSINESS

An opportunity to acquire office space adjacent to the current health district office has become available. It has been used for our flu and covid vaccination clinics and would be a good space for additional community programs. The Board has approved Neal Lustig to negotiate with the owner on purchasing this unit.

Deputy Health Director- A part-time position of Deputy Health Director was created whose salary will be covered by various grant funding. Richard Hunter made a motion to approve, Anne Neumann seconded, approved unanimously by the Board.
